

Terms and Conditions for e-Auction Bidder Registration

Chhattisgarh Rajya Van Vikas Nigam Limited (C.G. Forest Development Corporation)

The following **Terms and Conditions** (hereinafter referred to as "T&C") are applicable to all participants (hereinafter referred to as "Bidders") who wish to participate in the e-Auction process conducted by **Chhattisgarh Rajya Van Vikas Nigam Limited** (hereinafter referred to as "CGFVNL" or "Corporation") for the sale of timber, forest products, and other related goods.

1. General Terms

1.1. The e-Auction is governed by the **Chhattisgarh Rajya Van Vikas Nigam Limited** rules and regulations, including all applicable laws and policies.

1.2. Bidders must ensure they are registered with the **CGFVNL** and meet all the eligibility criteria for participation in the e-Auction.

1.3. Registration for the e-Auction is subject to approval by **CGFVNL**. The bidder's participation will be allowed only after successful registration and verification of the required documents.

2. Eligibility Criteria

2.1. Only individuals, companies, firms, or institutions who meet the following criteria are eligible to participate in the e-Auction:

- Valid **GST Registration** (where applicable).
- Proof of identity (Aadhar, PAN, or any government-issued ID).
- Proof of address.
- Business/Trade License (if applicable).
- Any other documents as required by **CGFVNL**.

2.2. Bidders must not have been debarred or blacklisted by the Corporation or any other government body.

3. Registration Process

3.1. To register for the e-Auction, the bidder must submit the **online registration form** available on the official **CGFVNL** website.

3.2. The bidder must upload scanned copies of all required documents. Incomplete applications will be rejected.

3.3. The bidder will receive an acknowledgment upon successful submission of the registration form, but this does not imply approval of registration.

3.4. Upon approval, the bidder will receive login credentials (username and password) to access the e-Auction platform.

4. Bidder Obligations

4.1. Bidders are required to keep their registration information up to date at all times.

4.2. Bidders are responsible for the security and confidentiality of their login credentials. Any unauthorized use of the credentials will be the responsibility of the bidder.

4.3. Bidders must ensure that all bids placed on the platform are within their financial capacity and

comply with the auction guidelines.

4.4. In case of any dispute regarding the registration or participation in the auction, **CGFVNL's** decision shall be final and binding.

5. Auction Process

5.1. Bidders must follow the **e-Auction schedule** as published on the official website.

5.2. The starting price and bidding increments for each auction lot will be clearly mentioned on the auction platform.

5.3. Bidders must place their bids in the prescribed format. No verbal or manual bids will be entertained.

5.4. **CGFVNL** reserves the right to cancel or postpone any auction without providing any reason.

5.5. The bidder with the highest valid bid at the close of the auction will be declared the **successful bidder**.

6. Payment Terms

6.1. The **successful bidder** must make the payment as per the terms specified in the auction notice. Payment details, including the method of payment, will be provided on the e-Auction platform.

6.2. The payment must be made within the stipulated time frame. Failure to make timely payment will result in cancellation of the bid and forfeiture of the **earnest money deposit (EMD)**, if any.

6.3. In case of successful bidding, the bidder is required to complete all necessary documentation and payment formalities before the transfer of the goods.

6.4. Taxes and other applicable charges will be borne by the bidder in addition to the bid amount.

7. Auction Lot Delivery

7.1. The **successful bidder** is responsible for the transportation, handling, and storage of the auctioned goods at their own expense.

7.2. The bidder must take delivery of the auctioned lots within the time frame mentioned in the auction notice.

7.3. If the **successful bidder** fails to take delivery within the specified period, the Corporation may cancel the sale and forfeit the EMD.

8. Confidentiality and Privacy

8.1. The bidder agrees to keep all information related to the auction process confidential, including pricing and bidding strategies.

8.2. **CGFVNL** will not be responsible for any unauthorized access to the bidder's personal or financial information provided during the registration process.

9. Governing Law and Dispute Resolution

9.1. The **T&C** will be governed by the laws of **India**, and any disputes arising from the e-Auction process shall be subject to the exclusive jurisdiction of the courts located in **Raipur**, Chhattisgarh.

9.2. Any disputes, differences, or claims shall first be attempted to be resolved through **mediation**. If unresolved, the matter may be referred to arbitration in accordance with the **Arbitration and Conciliation Act, 1996**.

10. Liability and Indemnification

10.1. **CGFVNL** will not be liable for any loss, damage, or injury incurred by the bidder during the e-Auction process, delivery, or use of the auctioned goods.

10.2. The bidder agrees to indemnify and hold harmless **CGFVNL**, its officers, and agents from any claims, losses, damages, or expenses arising out of the bidder's participation in the e-Auction.

11. Amendments to Terms and Conditions

11.1. **CGFVNL** reserves the right to modify or amend the Terms and Conditions at any time without prior notice. The updated T&C will be published on the official website, and it is the bidder's responsibility to review the T&C before participating in each auction.

12. Miscellaneous

12.1. These **Terms and Conditions** represent the complete understanding between the bidder and **CGFVNL** regarding participation in the e-Auction process.

12.2. If any provision of these terms is found to be invalid, the remaining provisions will continue to remain in full force and effect.
